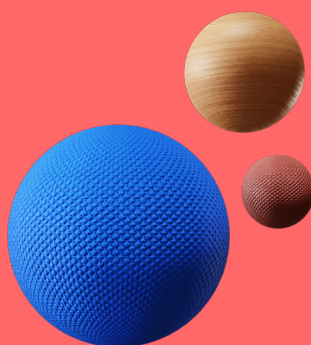

# What is the EDIH Network?

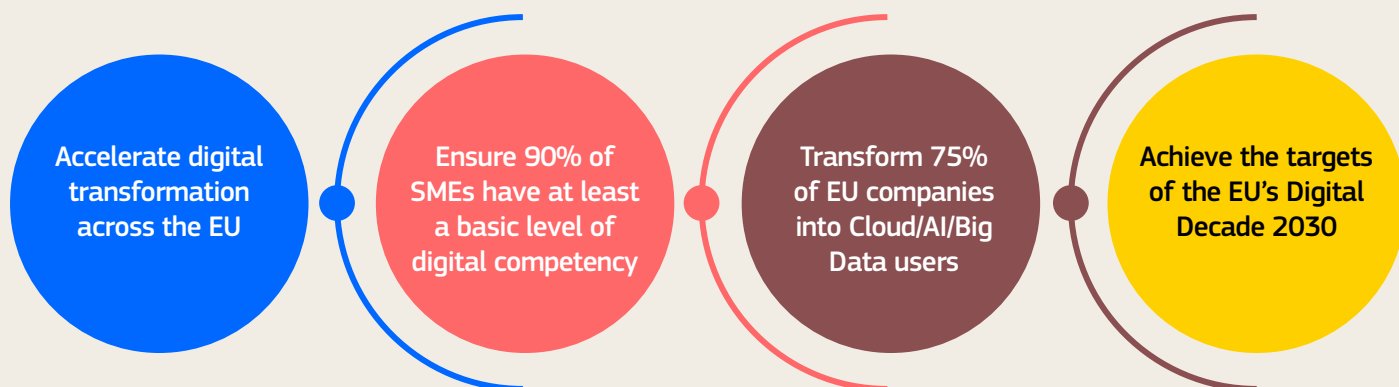
